Deputy Supervisor Presley joined the meeting at 6:35 p.m.


## **Bridge and Pier Update**

Saratoga put in a call to the lowest bidder for the Bridge project, they did not hear back yet. The bid is about \$400,000 over original estimates.

#### **Pier Project Response Letter**

The Board gave the following response letter from Attorney Ryan to Steven Veley about the Pier Project.

The Town would have had the right to consider the proposal applying all of the selection criteria, not just experience and level of service and reach with proposers modifications to the original submitted proposal.

Regarding your paragraph "Thirdly", other than general liability insurance, the Board has no other information that the RFP insurance requirements match the services currently provided by KWS. In Section VI (Scope of Services, subparagraph 10) the RFP states: "Final insurance requirements may vary based on the operating plan of the designated operator". The specific coverages that would be required would be determined based upon the types of services rendered by the designated operator. A potential proposer could have submitted a proposal that did not include all of the services mentioned within the Scope of Services. However, that proposer's financial offer might be the most favorable to the Town. The Board would have the right to select that proposal even though it did not provide for all of the requested services. Insurance coverages for services not provided would not be necessary.

Addressing your paragraph "Lastly", the reason for the request is directly related to the State grant that the Town has been awarded in the amount of Four Hundred Ten Thousand Dollars (\$410,000.00). In order to receive the entire grant amount, the Town must invest in the project the amount of \$2,063,000.00. The grant provides that any in kind services or purchases/investments made by the Town or the designated operator on or after December 10, 2015 may be applied to meet the investment requirement of \$2,063,000.00. If this amount is not achieved, then the grant award will be reduced in the same proportion that the total investment is less than the mandated threshold of \$2,063,000.00.

In conclusion, the Town Board firmly rejects your assertion that "the RFP process was structured in order to favor KWS alone".

#### LOCAL LAW NO. 2 OF 2020 OF THE TOWN OF URBANA, N Y.

TITLE: PROVISIONS OF PARAGRAPH (a) OF SUBDIVISION 1 OF SECTION 581 OF RPTL AND PARAGRAPH (b) OF SUBDIVISION 1 OF SECTION 339-Y OF RPL NOT APPLICABLE

**BE IT ENACTED BY the** Town Board of the Town of Urbana, N.Y. as follows:

#### Section 1

The Town Board hereby adopts this Local Law to provide that the provisions of paragraph (a) of Subdivision 1 of Section 581 of the Real Property Tax Law shall not apply to converted condominium units within the Town of Urbana. A converted condominium unit tor purposes of this paragraph shall mean a dwelling unit held in condominium form of ownership that has previously been on an assessment roll as a dwelling unit in other than condominium form of ownership and has not been previously subject to the provisions of paragraph (a) of Subdivision 1 of Section 581 of the Real Property Law.

## Section 2

The Town Board hereby adopts this Local Law to provide that the provisions of paragraph (b) of Subdivision 1 of Section 339-y of the Real Property Law shall not apply to a converted condominium unit within the Town of Urbana. A converted condominium unit, for purposes of this paragraph, shall mean a dwelling unit held in condominium form of ownership that has previously been on an assessment roll as a dwelling unit in other than condominium form of ownership and has not been previously subject to the provisions of paragraph (b) of Subdivision 1 of Section 339-y of the Real Property Law.

#### Section 3

This Local Law shall take effect upon adoption and filing with the Secretary of State.

#### Adopt Local Law #3

## LOCAL LAW NO. 3 OF 2020 OF THE TOWN OF URBANA, NEW YORK

#### TITLE: AMENDMENT TO SECTION 18-2 OF THE TOWN CODE

BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF URBANA, NEW YORK

- Section 1. Section 18-2 of the Town Code is hereby amended to add a new subsection lettered (D) to read as follows:
  - "(D) If no activity or communication by the applicant regarding the the application within sixty (60) days from the date of the filing of the application, the application shall be deemed abandoned and the Board shall take no further action. The applicant may file a new application upon payment in full of all applicable fees.
- Section 2. This local law shall take effect upon adoption and its filing with the Secretary of State.

On a motion made by Councilman Luppino, seconded by Councilwoman Farmer and carried, Deputy Supervisor Presley abstained, the following resolution was adopted:

#### **RESOLUTION**

- WHEREAS, the Town of Urbana has established a dog park ('Park') consisting of two separate sections, one dedicated for small dogs and the other dedicated for large dogs; and
- WHEREAS, James Presley, a long time resident of the Town, has pledged to the Town a conditional donation of Ten Thousand and OO/IOOths Dollars (\$10,000.00), said funds to be used by the Town to defray the cost of the establishment, maintenance and upkeep of the Park; and
- WHEREAS, in consideration for his conditional donation, Mr. Presley has requested that the Town grant to him the "naming rights" to the Park and its sections; and
- WHEREAS, Mr. Presley requests that the Town Board name the Park the "Presley Memorial Dog Park", that the large dog run section be named "James L. Presley" and that the small dog run section be named "Samuel H. Presley, Sr." and
- WHEREAS, the donation is conditional on the fact that if at any time in the future during the Park's existence the Town Board authorizes a change of names of the Park and either or both of its sections, the Town shall pay to James Presley, if living, or if not living, to his distributees, the sum of Ten Thousand and OO/IOOths Dollars (\$10,000.00) within thirty (30) days from the Town Board's name(s) change authorizations).

NOW, THEREFORE be it RESOLVED THAT THE Town Board, with great gratitude to James Presley, hereby accepts his generous conditional gift of Ten Thousand and 00/1 OOths Dollars (\$10,000.00) said funds to be used by the Town to defray the cost of the establishment, maintenance and upkeep of the Park; and be it further

RESOLVED, that the Town Board does hereby name the Park the "Presley Memorial Dog Park; does hereby name the large dog run section "James L. Presley" and does hereby name the small dog run section "Samuel H. Presley, Sr."; and be it further

RESOLVED, that the Town Board agrees that if the Town Board, at any time in the future during the Park's existence, changes the name(s) of the Park or either or both of its sections, the Town shall pay to James Presley, if living or if not living to his distributees in equal shares, the total sum of Ten Thousand and 00/1 OOths Dollars (\$10,000.00) within thirty (30) days from the Town Board's name(s) change authorization(s).

#### **Property Reassessment**

David Oliver explained that this is the Town of Urbana's fourth year in the reassessment cycle. Next year there will be a property revaluation so we will be at 100 percent.

#### Wings and Wheels

The Curtiss Museum's Wings and Wheels event the weekend of September 19-20 is cancelled this year due to COVID-19. They would still like the planes to be allowed to come in on the same weekend and use the boat launch area and docks.

## **Boat Launch Gate**

The boat launch gate is not working at all and needs to replaced. The Town received 2 bids for the gate and Deputy Supervisor Presley will get one other bid. Deanna Tompkins will do more research on the bids.

## **Resignation-Fire Commissioner**

The Town Board accepted Paul Wilson's letter of resignation as Fire Commissioner

## **Public Input on Non Agenda Items**

Steven Veley asked questions about the financials of the Pier Project and wanted to know if the numbers that were submitted were correct.

Steven Veley asked why the Town stopped mowing the baseball field. Supervisor Stull will talk to the Highway Department.
